On this 30th day of October AD 1866,
personally appeared before me Judge of the Probate
Court for the District of Madison, Mary Jane
Norton a resident of Guilford in the County
New Haven & State of Connecticut, Aged 35 years
who being first duly sworn according to law doth
on her oath make the following declaration in
order to obtain the benefit of the provision
made by the second section of the act of Congress
increasing the pensions of widows & orphans
approved July 25, 1866.

That she is the widow of Francis M.
Norton who was a Sergeant Co. I, 14. Regt,
Conn. Cal., in the war of 1861, and that
by reason of his death in the service aforesaid
she has been granted a pension of eight dollars
per month in accordance with a certificate
numbered 46139, bearing date April 29th 1865

She further swears that she has the following
named children of her deceased husband & herself
under sixteen years of age who are now living the
date of whose births were as given below to wit,

George B. Born June 15th 1853
Hattie E. Born May 29th 1855
Stephen B. Born Nov. 18th 1857

remarried since the death of her said husband
nor has she abandoned the support of any one
of the children above named nor permitted
any one of the ~~children~~ same to be adopted
by any other person or persons as his her
or their child
