I have the honor to acknowledge the receipt from your Office of application for Pension No. 12,444, and to return it herewith, with such information as is furnished by the files of this Office.

It appears from the Rolls on file in this Office, that Abraham Tibbals was enrolled on the 3<sup>rd</sup> day of Oct., 1861, at Hartford in Co. "H", 10<sup>th</sup> Regiment of Conn Volunteers, to serve three years, or during the war, and mustered into service as a Private on the 3<sup>rd</sup> day of Oct., 1861, at Hartford, in Co. "H", 10<sup>th</sup> Regiment of Conn Volunteers, to serve three years, or during the war. On the Muster Roll of Co. "H" of that Regiment, for the months of July & Aug., 1862, he is reported as Died of disease August 8<sup>th</sup> 1862. Place of death not stated no further records on file.

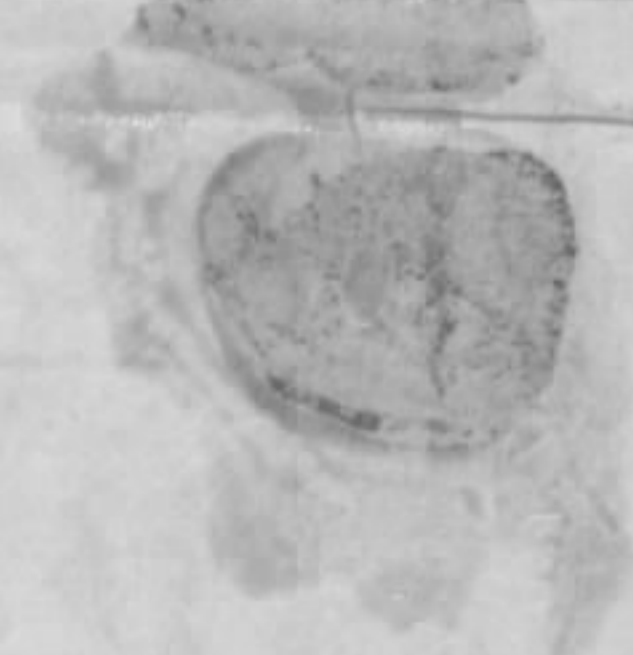

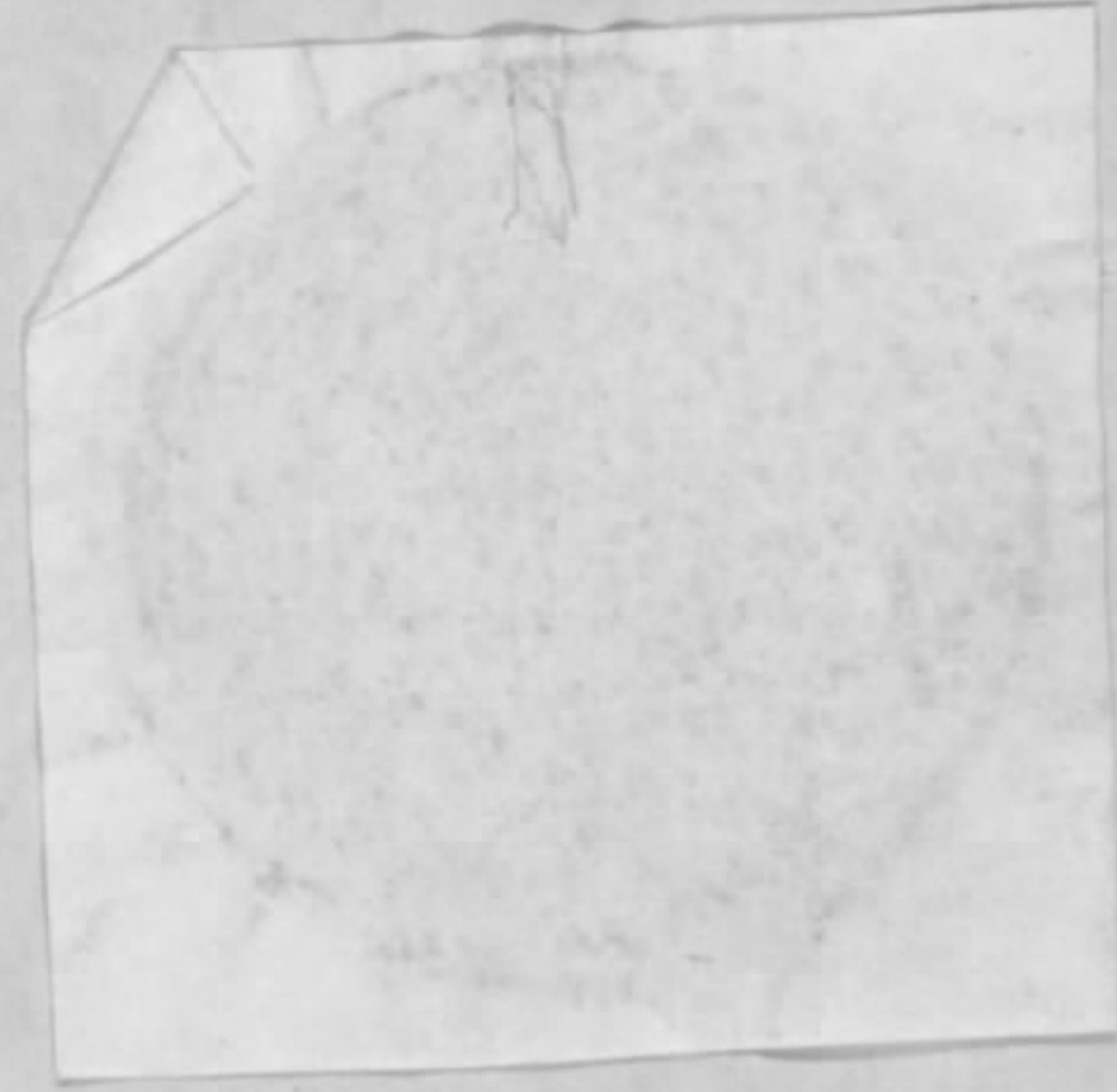
